

PABCO LIMITED SHINGLE WARRANTY

This warranty is valid when our shingles are purchased and applied in the United States or Canada. Specifically, we warrant that our PABCO® shingles are free from manufacturing defects that adversely affect their performance. The major warranty provisions and limitations described herein are listed in the table on the back for quick and easy reference.

- **Transferability:**

This warranty coverage automatically transfers to additional purchasers without any notification to PABCO® as long as the Warranty Limits described below have not expired.

- **Warranty Limits:**

Other than "Non-Ventilated Roof Decks" the warranty term varies from 20- to 50-years and it depends on the type of shingle purchased. Our warranty obligation to you ends when:

1. The shingles reach the end of their warranted life as set forth in the reference table.
2. The present owner re-roofs with another product.
3. A claim settlement has been reached.

- **Non-Ventilated Roof Deck Warranty Limit:**

Our warranty protection is limited to ten (10) years of prorated coverage for replacement of defective shingles only when our shingles have been installed over non-ventilated roof deck systems.

- **Non-Prorated Coverage:**

Our SG-30, Precise, Premier 30, Premier 40, Premier 50 and Premier Advantage shingles carry five years of non-prorated protection against manufacturing defects that adversely affect their performance. Our GG-20 shingles carry three years of non-prorated protection against manufacturing defects that adversely affect their performance.

This protection during the first three or five year non-prorated period includes the reasonable material and installation costs to repair, replace or recover as we determine after a formal claim has been processed and accepted. The only items we will not pay for are the disposal costs, metalwork, flashing or other related work.

After your "Non-Prorated Warranty Coverage" expires we will take into account the number of months of use that you have received through the date of your claim, and reduce the amount of payment to you accordingly for the balance of the warranty. This prorated coverage is described below.

- **Prorated Coverage:**

Protection during the balance of the warranty against manufacturing defects that adversely affect our shingles performance is known as the "Prorated Coverage" and it is limited to the reasonable cost of the shingle to repair, replace or recover the defective shingles as we determine after a formal claim has been processed and accepted.

AS AN EXAMPLE: Let's say that you used our Premier 30 shingle that is warranted for 360 months and you make a claim half way through year nine or in month (114). With that said, you have received 114 months of service out of the 360 month life leaving 246 months under the warranty. Our warranty obligation to you would be 246/360 or 68.33% of the reasonable cost of the shingles to repair, replace or recover your defective shingles.

ALTERNATIVE CLAIM REMEDY DURING THE PRORATED PERIOD: We reserve the right to provide replacement shingles as an alternative to paying the cost to repair or replace defective shingles, in our sole reasonable discretion.

- **Scotchgard™ Algae Resistant Roofing System:**

We warrant that our Premier 30 Scotchgard™ Algae Resistant Roofing System, Premier 40 Scotchgard™ Algae Resistant Roofing System and SG-30 Scotchgard™ Algae Resistant Roofing System will remain free from algae growth for a period of twenty (20) years. If algae growth does occur during this period we reserve the right to clean the algae from the shingles rather than repairing or replacing them.

- **Thermal Sealing Of Self-Sealing Shingles Defined:**

PABCO® shingles contain self-sealing asphalt strips that must be subjected to direct warm sunlight for several days before thermal sealing will occur. When shingles are installed during cool weather conditions they may not seal until the conditions warm or the seasons change. Shingles which do not receive direct sunlight or which are not exposed to adequate surface temperatures may never seal. This is the nature of self-sealing shingles and failure to seal under such circumstances is not a manufacturing defect.

- **Wind Warranty Protection:**

The following products (with their designated wind speed) carry five years of protection against wind damage up to the designated wind velocity (including gusts) following the proper application and sealing of shingles. Please see the reference table. Premier Advantage (110 mph), Precise (100 mph), Premier 50 (90 mph), Premier 40 (80 mph), Premier 30 (70 mph), SG-30 (60 mph).

Our GG-20 shingles carry three years of protection against wind damage due to wind velocities, including gusts up to a maximum of 60 miles per hour following the proper application and sealing of the shingles.

- **What Is Not Covered:**

PABCO is not liable under this limited warranty due to any cause other than for manufacturing defects in the shingles. While this warranty describes certain benefits available, it is not an assurance that the shingles will remain serviceable for the length of the entire warranty period. In addition, after our shingles leave the manufacturing facility, they are subjected to conditions and handling beyond our control that may affect their performance. This warranty does not cover such situations, nor does this warranty cover several events, including those listed below:

1. Defects or failure caused by application of the shingles not in strict adherence with our directions for application printed on the packaging;
2. Inadequate or ineffective ventilation. Ventilation requirements must meet current building codes;
3. Violent, unusual weather conditions or acts of God such as, but not limited to, hail storms, lightning, or winds greater than the wind limits stated above.
4. Wind damage that results from shingles that are manufactured correctly yet did not seal as described above in "Thermal Sealing Of Self-Sealing Shingles Defined";
5. Shingles applied with fewer than six (6) nails as indicated on our product packaging in areas where local knowledge indicates exposure to high winds may occur;
6. Variations in color or shading which may occur due to the positioning of the surfacing granules on our shingles.
7. Objectionable discoloration or contamination to the shingle arising from sources such as, but not limited to, moss, lichens or other vegetation, or plants, chemicals or other similar materials unless the applied shingle was sold as an "algae block shingle";
8. Damage caused by structural changes, alterations, additions, or by the installation of equipment such as signs or air-conditioning equipment to the structure after the original shingle installation;
9. Defects or failure of or damage caused by materials used as a roofing base over which the shingles are applied;
10. Damage to the roof caused by settlement, distortion, failure or cracking of roof deck, walls or foundation of a building;
11. Traffic on your roof;
12. Shingles installed on "Geodesic Dome" construction is not warranted nor approved under any circumstances;
13. Shingles installed over non-ventilated roof deck system will receive ten (10) years of prorated shingle coverage only;
14. Pabco reserves the right to discontinue or modify any of its products, including the color of the shingles, without notice to the present owner and shall not be liable for any such discontinuance or modification.

- **Limits on Liability:**

THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS THAT VARY FROM STATE TO STATE. THIS LIMITED WARRANTY IS EFFECTIVE ON SHINGLES APPLIED FROM JANUARY 1, 2002 TO DECEMBER 31, 2005. THIS LIMITED WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER GUARANTEES AND/OR WARRANTIES, ORAL OR WRITTEN, EXPRESSED OR IMPLIED (SUCH AS THOSE MADE BY DEALERS, CONTRACTORS, DISTRIBUTORS OR APPLICATORS OF THE SHINGLES), EXCEPT THAT THE DURATION OF ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE THAT THE ORIGINAL HOMEOWNER/CONSUMER MAY HAVE ARE LIMITED TO THE DURATION OF THE WRITTEN WARRANTY UNLESS A SHORTER PERIOD IS PERMITTED BY LAW. IN NO EVENT, SHALL PABCO ROOFING PRODUCTS BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, INCLUDING ANY DAMAGE TO THE BUILDING, ITS CONTENTS OR ANY PERSONS THEREIN. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS OR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. FURTHER, THE WITHIN LIMITED WARRANTY IS IN LIEU OF ALL OTHER THEORIES OF LIABILITY, CAUSES OF ACTION, AND CLAIMS WHATSOEVER, AGAINST PABCO.

- **The Claim Process:**

In order to initiate a claim against this warranty we must be notified within thirty (30) days of discovery of a claimed manufacturing defect, and before the warranty expires. You may call us at 1.800.426.9762 or 253.272.0374 so that a claim packet can be forwarded to you. You may also reach us at www.pabcoroofing.com or send us a letter addressed to Pabco Roofing Products, 1718 Thorne Road, Tacoma, WA 98421-3207.

When you receive your claim packet you will be required to fill out the homeowner's section completely, sign and date it, provide us with two full shingles that clearly demonstrate the claimed defect and provide us with photos so that we may understand the scope of your problem. All this required claim information is your responsibility and is to be forwarded to the address above at your cost before the warranty has expired as described above in "Warranty Limits".

Once received, we will analyze your claim according to the terms and limitations described in this warranty and formally respond to you.
